# **Terms and Conditions of music tuition for Helen Wilkins BA Hons Music, PGCE**

1. Fees April 2019 – March 2020:  
a) 30 minutes £17; b) 45 minutes £25.50; c) 60 minutes £34.
  
2. For lessons where I travel to you, additional costs may be added to lesson fees to cover my travelling time and transport costs.
  
3. I will provide a timetable by the first lesson of each Series. Please check carefully and let me know of any problems with the timetable within 7 days of receiving it.
  
4. Payment is to be made by the second lesson either by cheque, cash or bank transfer to Helen Wilkins.
  
5. 48 hours' notice is required for cancellation of any lessons listed on the timetable. With this notice I will try to offer you an alternative lesson slot in the same week, although this is not guaranteed. If less than 48 hours' notice is given, or I cannot re-schedule in the same week, then the lesson and payment will be forfeited.
  
6. Lessons that have been scheduled on the timetable that are cancelled by me will be carried forward, refunded or rescheduled.
  
7. If you decide that you no longer wish to receive keyboard/piano lessons please give 4 weeks' notice. Without this notice, payment for the next four lessons will be required.
